Terms and conditions for the provision of the number retention service (hereinafter referred to as Service terms and conditions)

1. Tele2 does not apply a charge for the number retention service within the mobile and/or landline electronic communications network (hereinafter – the Service) and will perform all necessary actions to transfer the End User's No. (Nos.) to the Tele2 network.
2. The Service Application (hereinafter referred to as the Application) is concurrently the authorisation from the End User to terminate the Contract(-s) with the Donor Operator regarding the transferred No. (Nos.) from the date of the activation of the No. (Nos.).
3. Tele2 will provide the information referred to in this Application to the Donor Operator in order to ensure provision of the service.
4. Provision of the Service is not possible if incomplete or false information about the End User is provided or if this data does not correspond to the data available to the Donor Operator and/or the End User has terminated the contract with the Donor Operator regarding the No. (Nos.) to be transferred.
5. In signing this Application, the End User attests and agrees that:
 - 5.1. He/she has studied the Service terms and conditions,
 - 5.2. Data provided in the application are correct,
 - 5.3. Termination of a contract with the Donor Operator does not release the End User from the obligation to pay for services provided.
 6. No later 1 (one) day before the activation of the mobile no. (nos.), Tele2 will send an SMS to the No. (Nos.), informing the recipient about the transfer date, when the No. (Nos.) specified in the Application will be activated within the Tele2 mobile communications network.
 7. If a landline phone network No. (Nos.) is/are transferred, Tele2 will inform the End User about the transfer date, when the landline number(-s) mentioned in this Application will be activated within the Tele2 network, sending the information to the following e-mail address [REDACTED].
 8. Tele2 will commence provision of the Electronic communications service after the Number(-s) have been activated within the Tele2 network.

If the transferrable No. (Nos.) is not activated within the Tele2 network for reasons beyond the control of Tele2, retention and re-registration of the No. (Nos.) will not take place and the concluded Contract will be annulled.

In the event that, as part of the provision of the number retention service, termination of the contract with the Donor Operator obliges the End User to make payment for services provided by the Donor Operator, the Applicants attest and agree that the person taking over the No. (Nos.) will make payment, concluding a separate agreement with Tele2.
